- 24. SALIM CONCLUDED HIS REMARKS BY CALLING FOR INTERNATIONAL ASSISTANCE FOR THE HOSTS OF THE REFUGEES. THE PEOPLE OF WESTERN TANZANIA AND EASTERN ZAIRE HAVE BEEN SUFFERING UNDER THE BURDEN OF THE REFUGEES AND THEIR PLIGHT CANNOT BE IGNORED.

ACCORDING TO BIZIMUNGU, THEY HAD BEEN THREATENED WITH DEATH IF THEY JOINED THE GOR. THE GOR TRIED TO BRING IN FORMER MEMBERS OF THE RWANDA MILITARY, WHO ALSO REFUSED. THE MRND WANTED TO REMAIN OUTSIDE SO THEY CAN EVENTUALLY ATTACK RWANDA, BIZIMUNGU ASSERTED.

44. WE BELIEVE THIS SUMMIT WAS MWINYI'S RESPONSE TO A/S MOOSE'S CALL FOR A REGIONAL CONFERENCE ON RWANDA AND BURUNDI. FOR THE

CASH-STARVED GOT, THIS ADD-ON TO THE OAU SUMMIT WAS A COST EFFECTIVE WAY TO CONTINUE ITS ROLE OF FACILITATOR. IT IS SIGNIFICANT THAT IN MWINYI'S SUMMARY OF CONCLUSIONS AND NEXT STEPS, HE DID NOT INCLUDE ANOTHER CONFERENCE. WHILE WE HAVE NOT BEEN ABLE TO GET AN AFTER-ACTION ASSESSMENT FROM THE MOFA, WE SUSPECT THAT MWINYI BELIEVES THAT HE HAS MET HIS REGIONAL OBLIGATION.

45. NOR DID MWINYI ENDORSE THE CONCEPT OF SEGREGATING THE REFUGEES. TANZANIA HAS BEEN UNDER PRESSURE TO INCREASE SECURITY IN AND AROUND THE CAMPS BUT HAS DELAYED, CLAIMING LACK OF RESOURCES AND ABSENCE OF A UN MANDATE. WE ASSUME THAT A CALL BY THE UNSC FOR THE REFUGEE HOSTING COUNTRIES TO DETAIN THOSE ACCUSED OF GENOCIDE WILL BE FORTHCOMING SOON. WE EXPECT THE TANZANIANS TO REPLY THAT THEY HAVE THE WILL TO DO SO BUT NOT THE ABILITY AND WILL RENEW THEIR REQUEST TO THE U.S., U.N. AND OTHERS FOR FINANCIAL ASSISTANCE.
