- 2. SUMMARY: QUAI POLITICAL AFFAIRS DIRECTOR RIVASSEAU TOLD US JULY 13 THAT THE GOF IS ANXIOUS TO HAVE THE UN MOVE FORWARD AS QUICKLY AS POSSIBLE UNDER RESOLUTION

- 935. HE BELIEVES CONSTITUTING A WAR CRIMES TRIBUNAL ALONG THE LINES OF WHAT IS BEING DONE FOR EX-YUGOSLAVIA WOULD BE APPROPRIATE, BUT THAT A LEGAL FRAMEWORK IS NECESSARY BEFORE FRANCE OR ANY OTHER NATION ACTS AGAINST WAR CRIMINALS. THE GOF PREFERS CONSULTATIONS ON RWANDA TO BE HELD AT THE UN, BUT RIVASSEAU WAS NOT PREPARED TO COMMIT TO A BILATERAL SESSION AND WILL GET BACK TO US. END SUMMARY.
- 3. WE SPOKE TO THE DIRECTOR OF THE QUAI'S OFFICE OF POLITICAL AFFAIRS, FRANCOIS RIVASSEAU, AND THE HUMAN RIGHTS DESK OFFICER FOR AFRICA JULY 13 TO PRESENT REFTEL TALKING POINTS. RIVASSEAU STATED THAT THE GOF IS ALREADY GATHERING INFORMATION, SOME OF WHICH IT HAS TRANSMITTED TO THE UN. IT IS PREPARED TO SUPPLY THE REST TO ANY PROPERLY CONSTITUTED BODY AND SEEKS USG HELP IN PUSHING FOR EARLY ARRIVAL IN RWANDA OF A UN COMMISSION UNDER RES. 935.

  BE APPROPRIATE. HE STRESSED THAT THE RWANDAN CASE WAS
  OF GREATER MAGNITUDE AND THE MECHANISM WOULD HAVE TO BE
  ADAPTED. THE GOF CURRENTLY IS REFLECTING ON THIS
  ASPECT. WITH REGARD TO ARRESTING AND DETAINING ACCUSED
  PERSONS, HE SAID, THE GOF DOES NOT HAVE MANY IDEAS.
  FIRST, HE POINTS OUT, FRANCE DOES NOT HAVE AUTHORITY

ACCORDING TO RIVASSEAU, FRANCE CURRENTLY HAS NO AUTHORITY TO ARREST PEOPLE FOR GENOCIDE, BECAUSE THE INTERNATIONAL CONVENTION HAS NOT YET BEEN ADOPTED INTO FRENCH LAW, ALTHOUGH A DRAFT LAW NOW IS UNDER CONSIDERATION. WHAT IS REQUIRED IS A SECURITY COUNCIL RESOLUTION REQUESTING ALL COUNTRIES TO ARREST WAR CRIMINALS WITHIN THEIR JURISDICTION, AS INVOKED IN THE RECENT CASE OF A SERB ARRESTED IN GERMANY FOR WAR CRIMES COMMITTED IN EX-YUGOSLAVIA. RIVASSEAU ADDED THAT SECURITY OF FRENCH TROOPS IN RWANDA WAS NOT A

DETERRING FACTOR. THE GOF WAS PREPARED TO ACT AS SOON
AS THERE WAS A JURIDICAL BASIS. HE FELT IT IMPORTANT
THAT ALL COUNTRIES OF THE REGION PARTICIPATE IN THE
ARREST OF WAR CRIMINALS.

6. AS TO A VENUE FOR CONSULTATIONS, RIVASSEAU DECLARED THAT FRANCE PREFERRED THE UN. HE WAS NOT PREPARED TO CONFIDENTIAL

7. RIVASSEAU EMPHASIZED THAT THE GOF WILL NOT ALLOW THE SECURITY ZONE ESTABLISHED BY FRENCH TROOPS IN RWANDA TO BECOME A REFUGE FOR WAR CRIMINALS, THOUGH HE NOTED FRENCH TROOPS CURRENTLY HAVE NO AUTHORITY TO ARREST OR DETAIN SUSPECTED WAR CRIMINALS THEY MAY
