1. ECOSOC ENDORSED THE UN HUMAN RIGHTS COMMISSION SPECIAL SESSION RESOLUTION ON RWANDA WITHOUT A VOTE DURING A 45-MINUTE MEETING JUNE 6. (TEXT OF ECOSOC DECISION IS FOUND IN PARA 2. U.S., GREECE FOR EU, CANADA, RUSSIA, NORWAY FOR THE NORDICS, PAKISTAN, AND JAPAN GAVE SUPPORTIVE STATEMENTS BEFORE THE VOTE, MANY NOTING THE POSITIVE PARTS PLAYED BY CANADA, CAMEROON, AND NIGERIA IN GENEVA. (SEE PARA 6 FOR TEXT OF U.S. STATEMENT.) CUBA ALSO SPOKE BEFORE THE VOTE, DEPLORING

THE SITUATION IN RWANDA AND UNDERLINING THE NEED FOR UN ACTION, BUT DECRYING THE LINKAGES BETWEEN HUMAN RIGHTS AND FUNCTIONS CUBA BELIEVES SHOULD BE RESERVED TO THE SECURITY COUNCIL. AFTER THE VOTE, CHINA REITERATED ITS STATEMENT AT THE UNHRC. RUSSIA AND NORWAY JOINED THE U.S. IN HIGHLIGHTING THE NEED TO BRING GROSS VIOLATORS OF HUMAN RIGHTS TO JUSTICE.

2. TEXT OF ECOSOC DECISION:

THE SITUATION OF HUMAN RIGHTS IN RWANDA

THE ECONOMIC AND SOCIAL COUNCIL ENDORSES RESOLUTION S-3/1 OF 25 MAY 1994, ADOPTED BY THE COMMISSION OF HUMAN RIGHTS AT ITS THIRD SPECIAL SESSION.

3. THE STATEMENT OF PROGRAMME BUDGET IMPLICATIONS (PBI) WAS DISTRIBUTED JUST BEFORE THE MEETING (FAXED TO IO/ESA). THE SUMMARY PARAGRAPH READS AS FOLLOWS:

THE PBI REFERS TO THE CONTINGENCY FUND, BUT NOTES THAT "NO ACTIVITY HAS BEEN IDENTIFIED FOR TERMINATION, DEFERRAL, CURTAILMENT OR MODIFICATION UNDER SECTION 21 OF THE PROGRAMME BUDGET FOR THE BIENNIUM 1994-95." IT ALSO NOTES THAT, "SHOULD IT NOT PROVE POSSIBLE TO MEET THE COSTS REQUIRED FROM THE CONTINGENCY FUND, THE IMPLEMENTATION OF THE RESOLUTION MAY HAVE TO BE POSTPONED, AS PROVIDED FOR IN THE GUIDELINES FOR THE USE AND OPERATION OF THE CONTINGENCY FUND . . . "
- 5. USUN UNDERSTANDS THE LANGUAGE IN PARA 4 ABOVE TO BE STANDARD. IT DOES NOT PREJUDICE THE LIKELIHOOD OF THE RWANDAN MANDATE BEING FINANCED FROM THE CONTINGENCY FUND. WE EXPECT THE CENTER FOR HUMAN RIGHTS WILL HAVE TO OUTLAY FUNDS PROGRAMMED FOR OTHER MANDATES WITH THE STRONG EXPECTATION THAT THE RWANDAN MANDATE WILL BE FULLY FUNDED BY THE CONTINGENCY FUND OR THROUGH THE

REDEPLOYMENT OF RESOURCES.

THE INTERNATIONAL COMMUNITY MUST WORK TO BRING SOLACE TO THE SUFFERING POPULATION OF RWANDA. TO THIS END, MY DELEGATION FULLY SUPPORTS THE RESOLUTION ADOPTED BY THE UN HUMAN RIGHTS COMMISSION IN SPECIAL SESSION.

THE INTERNATIONAL COMMUNITY HAS SEVERAL IMMEDIATE TASKS: TO STOP THE KILLING, ACHIEVE A CEASE-FIRE, PROVIDE HUMANITARIAN RELIEF, FACILITATE MEANINGFUL NEGOTIATIONS AND ASSIST IN INVESTIGATION OF HUMAN RIGHTS ATROCITIES. BUT THE WORLD COMMUNITY MUST ALSO CONSIDER STEPS THAT WILL PERMIT LONG-TERM RECONCILIATION, AND REPAIR THE DAMAGE THAT THIS CARNAGE HAS DONE TO THE MORAL AND LEGAL FABRIC OF OUR WORLD.

WORKING WITH ALL OF YOU TO DO WHAT WE MUST AT THIS CRUCIAL MOMENT. WE COMMEND THE HIGH COMMISSIONER FOR HIS COURAGEOUS VISIT TO RWANDA LAST MONTH.

WE WELCOME THE SIGNIFICANT CONTRIBUTIONS OF THE SECURITY COUNCIL, THE DEPARTMENT OF HUMANITARIAN AFFAIRS, THE UN HIGH COMMISSIONER FOR REFUGEES, GENERAL DALLAIRE AND HIS STAFF AND FORCES, THE UN HIGH COMMISSIONER FOR HUMAN RIGHTS AND SPECIAL REPRESENTATIVE BOOH-BOOH TOWARD ADDRESSING THIS MULTIFACETED DISASTER. WE MUST ALSO

THE U.S. WILL CONTINUE TO DO OUR PART. HIGH COMMISSIONER FOR HUMAN RIGHTS AYALA LASSO'S ROLE AS COORDINATOR OF HUMAN RIGHTS ISSUES THROUGHOUT THE UN SYSTEM IS OF COURSE VITAL IN THIS REGARD. NOT ONLY WILL THE MONITORS GATHER INFORMATION ON THE GROUND; THEIR VERY PRESENCE WILL FACILITATE THE NEGOTIATIONS, INASMUCH AS PARTIES WILL MORE WILLINGLY LAY DOWN THEIR ARMS TO THE EXTENT THAT THEY ARE UNDER INTERNATIONAL SCRUTINY.

GATHERING INFORMATION IS ONLY THE FIRST STEP. OUR GOAL MUST BE INDIVIDUAL ACCOUNTABILITY AND RESPONSIBILITY FOR GROSS VIOLATIONS OF HUMAN RIGHTS, IN RWANDA AND ELSEWHERE, NOW AND IN THE FUTURE.

LADIES AND GENTLEMEN, AS WE SIT HERE TODAY, OVER A QUARTER OF A MILLION REFUGEES FROM RWANDA ARE HUDDLED IN

TANZANIA ALONE. CORPSES STILL FLOAT DAILY DOWN THE KAGERA RIVER. WE MUST SEIZE THIS MOMENT TO REAFFIRM OUR COMMITMENT TO THE UNIVERSALITY OF HUMAN RIGHTS, TO THE RENUNCIATION OF POLITICAL VIOLENCE AND ETHNIC HATRED. WE MUST FIX RESPONSIBILITY ON THOSE WHO HAVE DIRECTED THESE ACTS OF VIOLENCE. IN SO DOING WE CAN TRANSFORM LIMITED OFFICIAL USE

IN CLOSING, MR. CHAIRMAN, THE UNITED STATES REGRETS THAT NEARLY TWO WEEKS HAS BEEN LOST IN IMPLEMENTING THIS VITAL MANDATE OF THE COMMISSION ON HUMAN RIGHTS. WE RECOMMEND THAT WAYS BE FOUND TO MAKE THE PROCESS MORE EXPEDITIOUS, PARTICULARLY IN EMERGENCY SITUATIONS.
