- 1. CONFIDENTIAL ENTIRE TEXT.
- 2. SUMMARY: CALM APPEARS TO REIGN IN KIGALI THE DAY AFTER MINISTER OF PUBLIC WORKS GATABAZI WAS BURIED OUTSIDE THE SOUTHERN UNIVERSITY TOWN OF BUTARE.

MBANWHILE, HABYARIMANA HAS CONVENED A MEETING OF POLITICAL LEADERS TO LOOK AT THE CONTINUING GOVERNMENTAL CRISIS. THE PRESIDENT APPARENTLY INTENDS TO SET UP ALTERNATIVE GOVERNMENTAL INSTITUTIONS, BUT I WARNED HIS ADVISORS OF THE DAMGERS IN SUCH ACTION. UN SECRETARY GENERAL BOUTROS BOUTROS GHALI ALSO CALLED THE PRESIDENT NIGHT 2/24 URGING HIM TO PROCEED WITH TRANSITION INSTITUTIONS. END SUMMARY.

- 3. RWANDAN CLERGY AND GOVERNMENT OFFICIALS CONDUCTED THE FUNERAL OF FELICIEN GATABAZI, MINISTER OF PUBLIC WORKS, IN SOLEMN DIGNITY AT THE BUTARE REGIONAL STADIUM. IN ADDITION TO REPRESENTATIVES FROM ALL MAJOR POLITICAL PARTIES AND THE PRESIDENCY, MOURNERS INCLUDED RPF'S BIZIMUNGU AND TITO RUTAREMARA AND COMS FROM FRANCE, BELGIUM, SWITZERLAND, UNICEF AND MYSELF.
- 4. THE MECHANISMS SET UP TO HANDLE AN OVERFLOW CROWD AND LEAD THEM THROUGH A LENGTHY MASS AND INTERMENT CONFIDENTIAL

CBREMONIES DEMONSTRATED RWANDAN CAPACITY TO DO THINGS
RIGHT IF THEY SO DESIRE. THE FUNERAL PREPARATIONS
ALSO SHOWED HOW MUCH OF RWANDAN POLITY AND CIVIL
SOCIETY IS STILL INTACT. GENDARMERIE SMARTLY
PERFORMED THEIR POLICING ROLES, THE ARMY PROVIDED AN
HONOR COMPANY, POLITICIANS OF ALL STRIPE PARTICIPATED
IN THE CEREMONIES. THE MASS WAS LED BY A TUTSI
BISHOP WHO HAD BEEN GATABAZI'S TEACHER MANY YEARS AGO

ON RETURN TO KIGALI AFTER THE FUNERAL AND INTERMENT AT SAVE MISSION STATION (RWANDA'S OLDEST CATHOLIC MISSION), I FOUND THAT RTLM (PRO-HABYARIMANA RADIO) HAD PUBLICLY DISCUSSED THE POSSIBILITY OF A GOVERNMENTAL CHANGE AS THE RESULT OF PRESIDENT'S MEETING WITH PARTY OFFICIALS TODAY. WE HAD NOT PREVIOUSLY DISCERNED THAT THE PRESIDENT INTENDED TO USE THIS ALL-PARTY GATHERING TO FORM A NEW GOVERNMENT.
- 6. AFTER NUMEROUS EFFORTS, I FINALLY REACHED THE PRESIDENT'S LEGAL ADVISER AND CABINET DIRECTOR. I TOLD THEM BOTH THAT THE RWANDAN POLITICAL SYSTEM HAD ENTERED A NEW ORDER WHEN THE PRESIDENT WAS SWORN IN AS PART OF THE ARUSHA INTERIM ARRANGEMENT ON 1/5. WE

NOW LIVED IN A POLITICAL VACUUM THAT COULD ONLY BE FILLED BY PROCEEDING TO INSTALL THE INTERIM ANY GOVERNMENT SET GOVERNMENT AND NATIONAL ASSEMBLY. UP OTHERWISE MIGHT BE CONTRARY TO THE CONSTITUTION AND THE FUNDAMENTAL LAW (THE ARUSHA ACCORD).

QUERY WASHINGTON REGARDING OUR COOPERATION WITH ANY GOVERNMENT OTHER THAN A TRANSITIONAL GOVERNMENT UNDER I WANTED TO GET THIS MESSAGE TO THE ARUSHA ACCORD. THE PRESIDENT, NOT AS A DICTATE OR CHALLENGE, BUT SO THAT HE WAS FULLY INFORMED ON THE SERIOUSNESS OF THE ISSUE UNDER CONSIDERATION AND WOULD NOT BE SURPRISED

SUBJECT: GATABAZI'S FUNERAL; PRESIDENT'S NEW

BY ANY SUBSEQUENT U.S. ACTIONS. IN THE NEXT CALL, CABINET DIRECTOR RUHIGIRA TOOK NOTE OF MY COMMENTS AND WENT IMMEDIATELY TO THE POLITICAL GATHERING. HE WAS ALREADY AWARE THAT THE ONLY STEP WE WOULD CONSIDER JUSTIFIED WAS A INITIATIVE TO INSTALL THE INTERIM GOVERNMENTAL INSTITUTIONS.

8. WHEN THE SECRETARY GENERAL'S SPECIAL REPRESENTATIVE BOOH BOOH RETURNED MY CALL AFTERNOON 2/25, I INFORMED HIM OF WHAT I HAD TOLD THE PRESIDENT'S COUNSELORS. HE SAID THAT UN SECRETARY GENERAL BOUTROS BOUTROS GHALI HAD CALLED THE PRESIDENT THE NIGHT BEFORE AND, THOUGH HE COULD NOT REVEAL ALL THAT HAD BEEN SAID, THE SECRETARY GENERAL HAD URGED THE PRESIDENT TO STOP DALYING AND GET THE INTERIM INSTITUTIONS ESTABLISHED. BOOH BOOH SAID THAT UN VIEW ON THIS PRIORITY COINCIDED PRECISELY WITH OURS.

9. CALM HAS RETURNED TO KIGALI. THE STREETS SEEM BACK TO NORMAL. AT A TOWN MEETING NOON 2/25, WE SAW OFFICIAL AND UNOFFICIAL AMERICANS FROM ALL OVER TOWN. THE PREFECTURE, AFTER A LONG MEETING ON SECURITY, HAS DECIDED TO CONTINUE THE CURFEW THROUGH THE WEEKEND. WE WILL MAINTAIN REGULAR UPDATES ON THE SITUATION TO THE AMERICAN COMMUNITY THROUGH OUR WARDEN NET.

10. COMMENT: WE CAN HOPE THAT THE SECRETARY
GENERAL'S CALL TO THE PRESIDENT AND MY OWN WARNING
SHOTS ACROSS THE BOW DETERRED HIM FROM TRYING TO
RECREATE GOVERNMENT OUTSIDE THE ARUSHA CONTEXT, BUT
WE WILL HAVE TO AWAIT THE RESULTS OF TODAY'S
MEETING. RPF IS MEETING WITH MDR FACTION OF FORMER
PRIME MINISTER NSENGIYAREMYE AT OUR RESIDENCE
TOMORROW AT 10:00 A.M. IN ANOTHER CONFIDENCE-BUILDING
EXERCISE. I WILL SOLICIT THEIR VIEWS AT THAT TIME.

11. WE WERE VERY CLOSE TO A GLOBAL AGREEMENT ON MONDAY. SOMEONE CLEARLY DID NOT WANT INSTITUTIONS TO BE INSTALLED AND TOOK DRACONIAN MEASURES TO PREVENT THIS. IT IS DISCONCERTING TO HEAR RWANDANS BLAME, WITH EQUAL FERVOR, THE PRESIDENT, THE PRIME MINISTER-DESIGNATE OR THE RPF. THIS DISPUTE ABOUT WHO WOULD WANT TO KILL GATABAZI IS BUT A REFLECTION OF THE DEEP DISTRUST THAT STILL SEPARATES THE PUTATIVE PARTNERS IN THE RWANDAN PEACE PROCESS. YET THE CENTRAL COHESION OF RWANDAN SOCIETY AND ITS CAPACITY FOR GOOD HAS BEEN DEMONSTRATED IN ITS DIGNIFIED FAREWELL TO PUBLIC WORKS MINISTER THE IMPRESSIONS OF THAT EVENT MAKE THE GATABAZI. ARUSHA PEACE ACCORD WORTH OUR CONSTANT EFFORT AND CONTINUING PRESSURE ON RWANDANS TO GET THE INSTITUTIONS IN PLACE. END COMMENT. RAWSON
