- 1. CONFIDENTIAL ENTIRE TEXT.
- 2. RWANDAN PRESIDENT HABYARIMANA RECEIVED DEPUTY ASSISTANT SECRETARY OF DEFENSE (DASD) FOR HUMANITARIAN AFFAIRS PATRICIA IRVIN AFTERNOON 3/24 FOR AN HOUR-LONG VISIT. THE PRESIDENT WARMLY WELCOMED DASD IRVIN NOTING THAT HER VISIT WAS A SIGN OF UWITED STATES SYMPATHY FOR RWANDA AND SUPPORT FOR

ITS NEEDS. HE ASKED HER TO THANK HER GOVERNMENT FOR ALL ITS HELP IN THE DIFFICULT THREE YEARS OF RWANDA'S RECENT HISTORY, ESPECIALLY HELP ON DISPLACED PERSONS.

- 3. DASD IRVIN EXPRESSED TO THE PRESIDENT HER DELIGHT IN BEING IN RWANDA AT THIS HISTORIC JUNCTURE. SHE HOPED THAT THE RWANDAN AUTHORITIES WOULD SOON BE ABLE TO PUT IN PLACE THE TRANSITION GOVERNMENT AND NATIONAL ASSEMBLY SO THAT U.S. PROGRAMS OF ASSISTANCE TO RWANDA COULD GO FORWARD. SHE THEN OUTLINED THE FUNCTIONS OF HER OFFICE AND THE PARTICULAR ROLE IT PLAYS IN HUMANITARIAN AFFAIRS, PEACEKEEPING AND SUCH OPERATIONAL ACTIVITIES AS DEMINING. IN OUTLINING HER ITINERARY TO AFRICA, SHE NOTED THE PARTICULAR INTEREST WHICH RWANDA HELD DUE TO THE PEACEKEEPING ACTIVITIES HERE AND THE CHALLENGE OF BRINGING A BETTER LIFE TO WAR-WEARY RWANDANS.
- 4. THE PRESIDENT INFORMED DASD IRVIN THAT THE GOVERNMENT WAS READY TO SET UP TRANSITIONAL CONFIDENTIAL

THE PRESIDENT TURNED TO HIS DIRECTOR OF CABINET WHO MENTIONED THE CDR'S EXCLUSION FROM THE ASSEMBLY. THE AMBASSADOR REITERATED U.S. STRONG SUPPORT FOR INCLUSION OF ALL POLITICAL FORCES AND RECOUNTED THE RECENT EFFORTS OF STATE DEPARTMENT HIGH OFFICIALS TO CONVINCE THE PATRIOTIC FRONT ON THIS POINT. THE AMBASSADOR THEN ASKED IF THE PRESIDENT COULD GIVE ASSURANCES THAT THIS WAS THE ONLY REMAINING ISSUE. 5. COMMENT: TWO HOURS AFTER THIS HEARTENING WORD,
THE PRESIDENT'S DIRECTOR OF CABINET SUBMITTED TO THE
PRIME MINISTER A LIST OF DEPUTIES WHICH THE PRESIDENT
WOULD BE SWEARING IN THE NEXT DAY. THIS LIST DIFFERED
IN THREE RESPECTS FROM THE LIST THE PRIME MINISTER
HAD PREVIOUSLY ANNOUNCED: A DIFFERENT NAME EACH FOR

7. PARTIES EVENTUALLY EVOLVED A CONSENSUS TO THE EFFECT THAT CHALLENGES IN ISLAMIC PARTY AND THE MDR SHOULD BE LEFT TO THE COURTS. PATRIOTIC FRONT REPRESENTATIVES WERE, HOWEVER, ADAMANT THAT THEY COULD NOT ACCEPT IMMEDIATE INSTALLATION OF THE CDR IN THE NATIONAL ASSEMBLY. THE CDR WOULD HAVE TO PROVE ITS GOOD INTENTIONS.
