SOLUTION IN THE CND COMPOUND THESE PEOPLE WILL BE SENT OUT AND PUT UNDER THE PROTECTION OF THE GENDARMERIE WITH UNCIVPOL MONITORING.

B. SECTORS.

(1) KIGALI. COMD SEC KIGALI HAD A MEETING WITH THE HOME MINISTER OF RWANDA ABOUT THE PROHIBITION OF DEMONSTRATIONS ON WITHIN 1.5 KM FROM THE CND COMPOUND. CONDUCTED VEHICLE AND FOOT PTL IN KIGALI CITY IN ORDER TO ENSURE KIGALI WEAPON SECURE AREA. ESTABLISHED 6 CHECK POINTS AT DIFFERENT PLACES IN KWSA. PROVIDED 2 UNMO ESCORTS TO GENDARMERIE, 2 FOR RPF, 1 FOR REFUGEE CAMP AND 1 TO TANZANIAN BORDER. ALSO PROVIDED ARMED ESCORTS FOR THE PRIME MINISTER, RPF AND UNDP. SECURED THE LOCATION OF THE RPF BATTALION IN KIGALI CITY, THE PREMATURE, FORCE HQ AND SEC HQ AND PROVIDED SECURITY TO THE AIRPORT OF KIGALI. DURING THE NIGHT ASSURED PROTECTION FOR THE PRIME MINISTER, THE PRIME MINISTER DESIGNATE, THE PRESIDENT OF THE CONSTITUTIONAL COURT AND FIVE OPPOSITION MINISTERS, AND TO THE RESIDENCE OF SRSG.

(2) DMZ. RGF SOLDIERS INTENDED LOOTING SHOPS AT RUHENGARI BECAUSE OF NOT BEING SERVED WITH BEANS IN THEIR MEALS. THE SUPPLIERS CLAIM THAT THEY HAVE NOT BEEN PAID FOR THEIR SERVICES SINCE A LONG TIME AND THEY REFUSE FURTHER SUPPLY. PROVIDED ESCORT TO IAAH FOR FOOD DISTRIBUTION AND MEDICAL CARE FOR CHILDREN AT RWANKURA AND GASIZA. ALSO MONITORED THE FOOD DISTRIBUTION FROM ICRC AT NYAMUGALI. AID WAS GIVEN TO 4,200 REFUGEES.

C. MILOB. ESCORTED RPF TO FROM MULINDI. ONE UNMO TEAM WAS SENT TO THE TANZANIAN/RWANDAN BORDER FOR ESCORT OF APC/TRUCK CONVOY FROM DAR ES SALAAM. MEETING WAS HELD BETWEEN MILOB RGF PROCE TEAM AND G3 RGF. A PROGRAM WAS AGREED UPON TO START AN OFFICIAL PROCE OF THE RGF ZONE. RGF AGREED ALSO ON CO-LOCATION OF MILOB HQ AT RUHENGARI AND BUTARE.

D. UNOMUR. THE SITUATION IN THE UNOMUR AREA IS CALM. UGANDA IS OBSERVING LIBERATION DAY TODAY 26 JAN. IT SEEMS THAT LUBIRIZI/KASHEKYE AREA IS CONFIRMED AS A CROSSING POINT FOR REFUGEES. A GROUP OF REFUGEES, ABOUT 10 PEOPLE WITH APPROXIMATELY 200 COWS CROSSED THE BORDER AT KASHEKYE TO RWANDA AT 251215 JAN 94. IT CAME OUT FROM DISCUSSION THAT THIS PEOPLE CAME FROM THE REFUGEE CAMP LOCATED AT MBARARA CARRYING PERMISSION CERTIFICATE FROM MBARARA AUTHORITY. ANOTHER GROUP OF 10 TO 15 REFUGEES CROSSED THE BORDER AROUND 15.00 HRS WITH APPROXIMATELY 100 TO 150 COWS AND WITH LOT OF LUGGAGES THROUGH LUBIRIZI AND KASHEKYE. NO INFO REGARDING THEIR LOCATION OF ORIGIN COULD CONFIRM. SPECIAL PTL WAS CONDUCTED TO FIND A PROPER PLACE FOR A SECOND REPEATER STATION FOR COMMUNICATIONS IN THE UNOMUR AREA. TOTAL 6 VEHICLES CROSSED THE BORDER AT GATUNA. TWO OF

THEM CAME FROM UGANDA TO RWANDA WITH TWO PASSENGERS CARRYING SMALL QUANTITY OF MITOKE. 4 VEHICLES WITH 8 PASSENGERS CAME FROM RWANDA. THEY HAD NO LUGGAGE WITH THEM.
