## SITREP COVERING PERIOD 130600B FEB TO 140600B FEB 94.

- 1. GEN SITUATION: CALM. ON: 131930 FEB 94 A SINGLE GRENADE EXPLOSION SOUND WAS REPORTED BY THE GENDARMERIE AT REMARA NEAR A SCHOOL NAMED LAMSEA. NO INJURIES WERE REPORTED. A PERSON WAS STABBED IN FRONT OF KING FAISAL HOSPITAL AND WAS ADMITTED IN THE HOSPITAL.
- POLITICAL ACTIVITIES. BROAD BASED TRANSITIONAL GOVERNMENT NOT YET INSTALLED. ON 131500B A MEETING WAS SCHEDULED TO BE HELD BUT IT WAS DELAYED AND STARTED AT 17.00 HRS. THE MRND AND THE MUGENZI FACTION OF THE LIBERAL PARTY (PL) DID NOT ATTEND THE MESTING. NO DECISION WAS REACHED ON THE POSSIBLE SWEARING IN CEREMONY WHICH WAS EXPECTED TO BE HELD ON 14 FEB 94. ON THE SAME DAY AT 13.00 HRS THERE WAS MEETING OF RPF AT CND COMPOUND WHICH WAS ATTENDED BY APPROXIMATELY 1500 PERSONS. ABOUT 100 SUPPORTERS OF BOCIAL DEMOCRATIC PARTY LEFT KIGALI TO ATTEND A POLITICAL MEETING AT BUTARE AT 10.00 HRS ON THE SAME DAY.

- (A) RGF. LO HAS REPORTED THAT RPF ARE RECRUITING PERSONNEL THROUGHOUT THE COUNTRY AND MOVING THEM TO THEIR ZONE. THEY BELIEVE THAT IS WHY THE 8 VAN DRIVERS WERE ARRESTED FOR LAST WEEK.
