- SHELLING CONTINUED THROUGH OUT THE DAY, THE MAJOR BATTLE TOOK PLACE AROUND RWANDEX, GIKONDO AND KICHIKIRO AREA. IN THE MORNING HEAVY ARTY AND MORTAR FIRE EXCHANGE CONTINUED BETWEEN RPF AND RGF AT RUBONGO AREA NORTH OF KIA. RGF PIRED ARTY SHELLS TO THE CND BUILDING BROM GIKONDO AREA. RPF CONTINUED TIGHTENING UP THEIR GRIP IN THE CITY. RGF PUTTING UP SOME RESISTANCE IN DIFFERENT PARTS OF THE KIGALI CITY. NO SIGNIFICANT CHANGES IN THE DISPOSITIONS OF BOTH THE WARRING GROUPS.
