### SITREP COURTING PIRIOD 240500B MAY TO 241800B MAY 94.

- 1. GEN SITUATION. THE SITUATION IS STILL TENSE AND VOLATILE. NO SIGNIFICANT CHANGES IN THE BATTLE SCENARIO WITHIN THE CITY. RGF AND RPF ARE OBSERVING PARTIAL TRUCE. EXCHANGE OF FIRE BETWEEN TWO FACTIONS CONTINUED IN VARIOUS PLACES IN KIGALI CITY. RPF SHELLED AT HOTEL DIPLOMAT CAUSING THE DAMAGE OF WINDOW GLASSES. THEY ALSO EHELLED AROUND ICRC HOSPITAL VIOLATING TRUCE. RPF CONTINUED TO PUT PRESEURE ON THE RGF POSITIONS IN CITY. RGF STILL CONSOLIDATING THEIR POSITIONS AT PRESIDENTIAL GUARD REGIMENT LOCATED AT KIMIHURURA. MILITIA STILL CONTROLLING ROAD BLOCKS AND CHECK POINTS IN RGF CONTROLLED AREAS IN KIGALI CITY. THE SPECIAL ENVOY OF THE SECRETARY GENERAL MR. IQBAL RIZA, MAJ GEN BARRIL, AND MR. MODEM LAWSON FROM UNISON II HAVE ARRIVED AT UNAMIR FORCE HO AT 1145 HRS.
