- 1. GEN SITUATION. THE GENERAL SITUATION REMAINED CALM IN KIGALI CITY. CIVILIANS CONTINUED TO RETURN TO THE CITY DURING THE PERIOD. TENSION CONTINUED TO RISE IN GISENYI AS RPF ARE REPORTEDLY CONTINUING THEIR ADVANCE TOMARDS THE TOWN. OTHER PARTS OF THE COUNTRY REMAINED CALM. THE FRENCH ARE REPORTED TO HAVE CONTINUED TO ASSIST IN HUMANITARIAN ACTIVITIES TO THE HIGH INFLUX OF DISPLACED PROPLE ARRIVING GISENYI AND GONA FROM RUHENGERI. FC HELD DISCUSSIONS WITH THE INTERIM PRIME HINISTER, HR PAUSTIN TWAGWIRAMUNGU. CONTINUED TO ASSIST IN HOVEMENT OF DISPLACED PEOPLE FROM BYUNDA TO KIGALI. TOTAL HUMBER OF PEOPLE WHO MERE TRANSFERRED TODAY TO KIGALI WAS SIL. PLANNING AND PREPARATION FOR THE EXPANDED UMAMIR FORCE CONTINUED TODAY.
- 2. <u>POLITICAL ACTIVITIES.</u> THE INTERIM FRIME HIMISTER HR FAUSTIN THAGHIRAHUNGU MET FORCE COMMANDER TODAY. THEY DISCUSSED ABOUT THE CURRENT POLITICAL AND HILITARY SITUATION IN RHANDA. RPF IS LIKELY TO ANNOUNCE UNILATERAL CRASE FIRE BY TOHORROW.

3. FACTIONAL ACTIVITIES.

- A. RPF. RPF CONTINUED THEIR ADVANCE TOWARDS GISENYI CAUSING MORE PANIC TO THE GENERAL POPULATION IN THE AREA. HOWEVER THEY HAVE STOPPED THEIR ADVANCE IN GENERAL AREA KORA WHICH IS 25 KMB EAST OF GISENYI. THEY CONTINUED TO ASSIST CIVILIANS RETURNING TO SETTLE IN KIGALI CITY. HO CHANGE IN SITUATION HAS BEEN REPORTED FROM THE SOUTH OF THE COUNTRY. REPORTS INDICATE MASSIVE RECRUITMENT IN REFUGES CAMPS AND HAMY TRAINING CAMPS ARE BEING ESTABLISHED IN THEIR AREAS. THEY CONTINUED TO COOPERATE WITH UNAMIR PORCES IN HOVEMENT OF DISPLACED PEOPLE BACK TO KIGALI.
- B. RGF. RGF ARE REPORTED TO HAVE RETREATED TO GISENYI AND OTHERS CROSSING THE BORDER TO GOHA IN EAIRS. THE ZAIRIAN AUTHORITIES ARE REPORTED TO HAVE TRIED TO RETRIEVE HEAPONS AND GRENADES FROM THE RETREATING SOLDIERS AND INTERHANME. THIS EXERCISE HAS FAILED DUE TO LARGE NUMBERS OF RGF BOLDIERS CROSSING THE BORDER INTO GOHA, ZAIRE. THEIR MORALE AND PIGHTING SPIRIT HAS GONE DOWN.
- C. <u>HILITIA.</u> HILITIA AND INTERHANNE ARE ALSO REPORTED TO BE MOVING TOWARDS GISENYI AND OTHERS CROSSING THE BORDER TO GONA.

4. OHR MILITARY ACTIVITIES

A. FORCE HO. HORMAL ROUTINE STAFF WORK WAS CONDUCTED DURING THE PERIOD. FC' STAFF BRIEF WAS CONDUCTED AT 0800 HRS. HE HELD DISCUSSIONS WITH THE INTERIM PRIME MINISTER, MR PAUSTIN THAGWIRAMUNGU THIS MORNING. THEY DISCUSSED

ISSUES: RELATED TO THE CURRENT POLITICAL AND HILITARY SITUATION IN THE COUNTRY. PLANNING AND PREPARATIONS FOR THE EXPENDED UNAMIR FORCES CONTINUED DURING THE PERIOD. GHANBATT CONTINUED TRAINING ON APCS.

B. UNCOUR. AREA OF OPERATIONS REMAINED CAIM. CONDUCTED ROUTINE PATROLS IN THE AREA. DETAILS OF BORDER CROSSING BETWEEN UGANDA AND RHANDA WERE AS FOLLOWS:

- C. GHANHATT. CONTINUED TO TRAIN ON APCS. PROVIDED SECURITY AT KIA, ANAHORO STADIUM, FORCE HQ, HOTEL HERIDIEN AND KING FAISAL HOSPITAL. CONTINUED TO PROVIDE PROTECTION TO DISPLACED PEOPLE AT ANAHORO STADIUM, HOTEL HERIDIEN AND KING FAISAL HOSPITAL. PROVIDED ARMED ESCORTS TO COVER MOVEMENT OF THE PRIME MINISTER DESIGNATE.
- D. MILOB. PROVIDED ARMED ESCORT AND HONITORING TEAMS TO UN AND HUMANITARIAN AID AGENCIES, PROVIDED TEAMS FOR:
 - (1) ESCORT OF ONE TRUCK FROM KIGHTUNBA TO KIGALI.
 - (2) ESCORT FOR MSF TO THE FRENCH SCHOOL ORPHANAGE AND SOME MEDICINE FROM KING PAISAL HOSPITAL TO ST MICHEL CHURCH.
 - (3) ESCORTED HAC TEAH AND VISITED CENTRAL HOSPITAL, KIGALI PREFECTURE AND ICRC HOSPITAL.
 - (4) ESCORTED CHO FROM KIGALI TO GATURA AND BACK.
- E. FRENCH COALITION FORCES ACTIVITIES. CONTINUED TO PROVIDE HUMANITARIAN ASSISTANCE TO DISPLACED PEOPLE WITHIN THE HPZ. HIGH INFLUX OF DISPLACED PEOPLE CONTINUE TO MOVE AND SEEK REFUGEE IN THEIR HUMANITARIAN PROTECTED ZONE.

REMAINED VIGILANT NITHIN THEIR AREA AS RFF ARE REPORTEDLY CONTINUING: THEIR ADVANCE TOWARDS GISENYI. NUMBER OF DISPLACED PEOPLE ARRIVING IN THEIR PROTECTED ZONE IS REACHING VERY ALARMING AND REQUIRE HORE HUMANITARIAN RELIEF ITEMS.
