2. [REDACTED] NOTIFIED USUN POLOFF THAT UNAMIR FC DALLAIRE AND SRSG BOOH-BOOH HAVE VAINLY ATTEMPTED TO BROKER A CEASE-FIRE BETWEEN THE GOR AND THE RPF; THE RPF CLAIMS THAT THE PROVISIONAL GOVERNMENT REPRESENTS THE SAME CLIQUE THAT SHATTERED THE PREVIOUS CEASE-FIRE AND THE ARUSHA ACCORDS. THEREFORE, THE 48 HOUR TRUCE (THAT IS SCHEDULED TO BEGIN APRIL 12, 6:00 AM KIGALI TIME) THAT ALLOWS FOR THE EVACUATION OF FOREIGN NATIONALS IS NOT A CEASE-FIRE BETWEEN THE PARTIES; THE RPF CLAIMS THAT THEY WILL MARCH ON KIGALI ONCE THE TRUCE ENDS.

3. [REDACTED] ALSO RELAYED THAT BECAUSE UNAMIR HAS BEEN UNABLE TO BROKER A CEASE-FIRE AND START POLITICAL NEGOTIATIONS, AND BECAUSE IT APPEARS THAT THE VIOLENT SITUATION IS LIKELY TO BECOME EVEN MORE SO, FC DALLAIRE IS PESSIMISTIC THAT UNAMIR CAN PLAY A CONSTRUCTIVE ROLE IN THE NEAR FUTURE; THEREFORE, DALLAIRE IS LEANING TOWARD RECOMMENDING THAT UNAMIR BE EVACUATED. NO DECISION WILL BE MADE FOR AT LEAST ANOTHER DAY.

4. BELGIAN POLOFF TOLD USUN POLOFF THAT ON APRIL 11 THE BELGIAN PRIME MINISTER ADDRESSED THE PARLIAMENT ON THE SUBJECT OF UNAMIR'S FUTURE, AND SAID THAT UNAMIR CAN NO LONGER PERFORM ITS MANDATE, AND THEREFORE MUST EITHER HAVE ITS MANDATE REDEFINED OR TERMINATED. [REDACTED]
