RESPONDING TO UN SECURITY COUNCIL RESOLUTION 935, SECRETARY GENERAL BOUTROS BOUTROS-GHALI ISSUED A REPORT ON JULY 26 ESTABLISHING A COMMISSION OF EXPERTS TO CONDUCT AN INVESTIGATION INTO THE ATROCITIES COMMITTED IN RWANDA (UN DOCUMENT NUMBER S/1994/879, 26 JULY 1994). THE THREE MEMBER COMMISSION, WORKING CLOSELY WITH THE SPECIAL RAPPORTEUR OF THE COMMISSION ON HUMAN RIGHTS, WILL BE LOCATED IN GENEVA.
- 3. THE COMMISSION'S WORK WILL BE DIVIDED INTO TWO STAGES. IN THE FIRST STAGE, MEMBERS WILL COLLECT AND REVIEW INFORMATION, A TASK EXPECTED TO TAKE SEVERAL WEEKS.
