THE COMMISSION WILL HOLD ITS FIRST FORMAL MEETING TODAY, THEREBY TRIGGERING ITS 4-MONTH MANDATE UNDER SECURITY COUNCIL RESOLUTION 935.
- 4. DRAWING ON TALKING POINTS IN REF (A), AMBASSADOR STRESSED THE IMPORTANCE OF THE COMMISSION AND THE NEED FOR EARLY ESTABLISHMENT OF A WAR CRIMES TRIBUNAL TO HELP STABILIZE THE SITUATION IN RWANDA.
