3. KEATING (NZ) LED OFF DISCUSSION PRAISING REPORT OF COMMISSION OF EXPERTS AND NOTING ITS GENERAL CONCURRENCE WITH JOINT NZ-US PROPOSED RESOLUTION AND STATUTE ESTABLISHING AD HOC TRIBUNAL FOR RWANDA. HE NOTED THAT

STATUTE WAS VERY SIMILAR TO YUGOSLAV TRIBUNAL STATUTE, BUT WAS RWANDA SPECIFIC WHILE UTILIZING APPELATE CHAMBER AND PROSECUTOR OF YUGOSLAV TRIBUNAL. HE ALSO STRESSED URGENCY OF SC ACTING EXPEDITIOUSLY. FRANCE, UK, RWANDA, RUSSIA, ARGENTINA, NIGERIA, DJBUTTI, OMAN WERE GENERALLY SUPPORTIVE.

- 4. RWANDA INDICATED SEAT SHOULD BE IN KIGALI; OTHER AFRICANS SPOKE OF "SOMEWHERE IN AFRICA OR A "NEUTRAL SITE IN AFRICA."
- 5. CHINA RAISED OBJECTION TO SECOND USE OF CHAPTER VII TO ESTABLISH SUCH A TRIBUNAL. SAID THEY DID NOT NECESSARILY OPPOSE TRIBUNAL, BUT QUERIED MODE OF ITS ESTABLISHMENT.
- 6. BRAZIL SAID THEY HAD DIFFICULTY WITH ASPECTS OF NZ-US PROPOSAL, BUT WOULD RAISE THEM DIRECTLY WITH CO-SPONSORS.

7. SPAIN (YANEZ-BARNUEVO) EXPRESSED STRONG PREFERENCE
FOR TWO STEP PROCESS FOLLOWED RE YUGOSLAVIA WITH SC
ADOPTING A RESOLUTION REQUESTING DRAFT FROM SYG AND THEN
ONCE DRAFT RECEIVED, ADOPTING SECOND RESOLUTION
APPROVING SYG'S DRAFT. HE ALSO COMPLAINED THAT SYG HAD
NOT ENDORSED REPORT OF EXPERTS OR EXPRESSED A VIEW ON
TRIBUNAL.

AMB INDERFURTH STRESSED THAT KEY ASPECTS OF NZ-US APPROACH WERE CONSISTENT WITH RECOMMENDATION OF EXPERTS. HE EMPHASIZED THAT REPORT OF EXPERTS AND RWANDAN STATEMENTS INDICATED NEED FOR URGENT ACTION. FAR AS PROPOSED TWO STEP PROCESS PROPOSED BY SPAIN. HE POINTED OUT THAT NZ AND US HAD WORKED CLOSELY WITH SECRETARIAT IN DEVELOPING OUR PROPOSAL, THAT SINCE WE HAD BENEFIT OF YUGOSLAV STATUTE CONCERNING WHICH LITTLE WAS CHANGED, IT MADE LITTLE SENSE TO FOLLOW TIME CONSUMING PROCESS OF TWO RESOLUTIONS. HE EXPRESSED HOPE THAT WE COULD RESPOND TO URGENCY OF THE SITUATION AND ASKED THAT THOSE WITH SUGGESTIONS OR PROBLEMS TO BE IN TOUCH WITH US AND NZ ASAP. HANNAY (UK) STRONGLY ENDORSED VIEW THAT TWO RESOLUTION PROCESS PROPOSED BY SPAIN WAS UNNECESSARY AND SIMPLY DELAYED AN URGENT MATTER.
