- 2. SUMMARY AND ACTION REQUEST. REFTEL OUTLINES FRENCH
 PROFOSAL FOR A MULTINATIONAL FRENCH-LED FORCE TO INTERVENE
 IN RWANDA AS SOON AS POSSIBLE TO FROTECT THREATENED
 CIVILIANS UNTIL THE REGULAR UNAMIR CONTINGENTS CAN
